Tell us a little about yourself and your family, how long you have lived in the area and your occupation.

I am a retired Fire Captain Paramedic from Southern California. I have an amazing wife Kate and 3 children, my daughter Lizzie (30 year old professional living in California) and two sons, Liam (21 year old senior at the University of Idaho) and Aiden (20 year old also attending University of Idaho).

I am an unapologetic Christian conservative who loves God, my family and my country. I have a strong desire for freedom with minimal government intervention. I believe in a constitutional representative republic and I want to keep it.

We moved to North Idaho in 2014 after buying a lot in the Cougar Bay area in 2012. We fell in love with North Idaho instantly after feeling the magic of this special and unique area of our country. North Idaho allowed us to openly express our conservative Christian values without the fear of repercussion from those with opposing views.

I currently work for the Kootenai County Sheriff's Office as a Community Service Officer. I needed to return to work for health insurance and the opportunity became available to serve the community once again in the public safety responder realm and I jumped at the opportunity.

1. Do you have experience as an elected official and if so, what was your position, and how would you describe your voting record?

I have never held or even considered running for a political office before, but I feel the need to not just be another one of the chronic complainers and enter into the fight to save our Republic.

I have been a lifelong Republican, voting for President Reagan in 1984, and have pretty much voted for the Party down ticket ever since. I have not always felt strongly about some of our candidates, but remained loyal to the Party.

2. Please tell us about your activity as a Republican. Have you previously voted for candidates of other parties? If yes, explain.

3. What is the purpose of government?

4. Describe why you are running for this particular office. What are your qualifications? What are your goals?

As a member of our local Firefighter association, I have worked in negotiations for the best outcomes for both sides to reach an acceptable common goal. I worked as a paramedic coordinator, so I understand how to work with the County and State oversight. I have served on many department committees and task force groups, so I understand the role of a commissioner as being only one of five opinions.

5. Describe experiences where you are or have been engaged such as non-profit organizations, clubs, churches, boards, commissions, etc., where you have been of service to others

I have served as a Board Member of TESH for over two years. TESH is a non profit group that helps disabled and challenged people find working roles to become contributing members of our community. I am a member of the Eagles and attend Candlelight Christian Fellowship for church. I have volunteered for my son's sports teams and assisted with fundraising for several groups.

6. Do you describe yourself as fiscally conservative? Please, elaborate.

Yes, I do describe myself as a fiscal conservative in both my personal finances and how our government spends taxpayer money. I have seen first hand the waste in government departments with the "we better spend it or we lose it" attitude. Our citizens understand the need for certain aspects of our government, such as public safety, education and community services. It is the duty of the governing bodies to be responsible with other people's money when providing these services. It is always easiest to spend other people's money for things you want or need because you don't have a personal stake in what you are spending. When granted power over others, you must have tremendous restraint over how you spend their money to serve them. We must understand filling a true need for serving the people over a want to have to serve the people.

7. Do you consider yourself socially conservative? Please elaborate.

Yes, I am a social conservative. It is amazing to me that if you say you believe in absolute truth, or that there is only one truth, you are now considered a dangerous extremist. I believe in God and the fear of God is the first step in knowledge. Knowledge is the understanding of truth and living by the principles of truth.
